The crucial role of upazila-level Child Welfare Boards in safeguarding and supporting children's rights in Bangladesh

However, it is disheartening to note that many of these boards are currently inactive and fail to hold the three monthly meeting stipulated in the act, let alone engage in other child-friendly activities. This unfortunate situation arises due to a lack of awareness among the board members regarding the operational areas and activities of the
